### **VOTING RESULTS OF ANNUAL GENERAL MEETING HELD ON 26 APRIL 2019**

At the AGM held on Friday, 26 April 2019, all the proposed resolutions as set out in the notice of AGM dated 25 March 2019 have been duly approved by the Shareholders by way of poll.

At the annual general meeting of UTS Marketing Solutions Holdings Limited (the “**Company**”) held on Friday, 26 April 2019 (the “**AGM**”), all the proposed resolutions as set out in the notice of AGM dated 25 March 2019 have been duly approved by the Shareholders by way of poll.

Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as ascribed thereto in the circular of the Company dated 25 March 2019.

#### **ATTENDANCE AT THE AGM**

As of the date of the AGM, the total number of the Shares in issue entitling the holder to attend and vote at the AGM was 400,000,000 Shares. Shareholders (in person or by proxy) holding an aggregate of 300,010,000 Shares, which represented approximately 75.0% of the total number of Shares, were present at the AGM.

There were no (i) Shares entitling the holders to attend and abstain from voting in favour at the AGM in accordance with Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) or (ii) shareholders of the Company that are required under the Listing Rules to abstain from voting at the AGM.
